

DOG PARTY USA

Pet Care Agreement and Liability Information

This is an Agreement between Dog Party USA, Inc, (Dog Party USA) and the pet owner/ client whose signature appears below (hereinafter referred to as "I," "me" or "my").

***Please acknowledge the following policy statements by initialing the space provided and signing at the bottom of the page.**

_____ For myself, my heirs and any assigns, I hereby release Dog Party USA, its agents, officers, employees, animal owners, customers and potential customers of Dog Party USA from any and all liabilities, financial or otherwise, for injuries to myself, my dogs, or any other property of mine which arise in any way from our services and/or products provided by or as a consequence of my association with Dog Party USA, in the absence of gross negligence.

_____ In consideration of the services rendered to the Guest or Client by Dog Party USA, the Guest/Client waives any and all claims, actions or demands of any nature, foreseen or unforeseen and he/she may have now, or in the future against Dog Party USA relating to the care, control, health, and/or safety of the Guest or Client arising during transport, drop-off, and stay at the facilities at which the Guest is being cared for.

_____ I understand that Dog Party USA expects Clients to bring their pet(s) for a temperament evaluation prior to boarding. Dog Party USA will give me an honest opinion of how my dog fared overall, whether they saw signs of stress, aggression or other problematic behavior, and will advise whether or not Dog Party USA is a good fit for my dog. Dog Party USA solely will make the determination whether its services are suitable for my dog.

_____ I understand my dog will have close contact with other dogs during group play. I understand that the owners and staff at Dog Party USA will not knowingly admit into the area dogs that are obviously aggressive in nature. I am also aware that disagreements can occur when guests become overzealous, however due to the benefits of dog socialization, I waive the risk. Therefore, I personally request a socialized environment for my pet while under the care of Dog Party USA.

_____ I agree to assume all liabilities and responsibilities, financial or otherwise, for the behavior and health of my pet. I agree to hold Dog Party USA harmless from any claims, actions, or demands against Dog Party USA arising during the stay at Dog Party USS in the absence of gross negligence.

_____ I authorize Dog Party USA to do whatever they deem necessary for the safety, health, and or well being of my dog while under the care of Dog Party USA. In the event of a medical problem I would like for my dog:

_____ to be taken to my regular veterinarian for care. By choosing this agreement I understand I am responsible for all charges incurred.

_____ to be taken to a veterinarian that Dog Party deems appropriate should my vet be unavailable.

_____ In the event of an after - hours emergency, I would like my dog to be taken to an emergency facility for care. By choosing this option I understand that I am responsible for all charges incurred.

_____ I agree to pay the rates for pet care provided and for additional services requested, if any, in effect on the date my pet(s) is/are checked into Dog Party USA as guest(s). I further agree that all charges shall be due and payable upon the departure of the pet(s) and that the pet(s) shall not leave Dog Party USA until all charges have been paid in full.

_____ All pets must have current vaccination records *including Bordetella within the last six (6) months* on file with Dog Party USA. Exceptions: If your pet has had an adverse reaction to a vaccination or your vet feels that due to age or health issues, a particular vaccine would be harmful, please have that information available to us.

_____ To the best of my knowledge, my pet has not been exposed to any contagious diseases within a thirty-day period prior to check-in.

_____ Once a male dog reaches maturity, if he has not been neutered, Dog Party USA cannot accept him. In an off-leash play setting an in-tact male can become the target of other dogs. This policy is for your dog's protection as well as other dogs and Dog Party staff.

_____ Pets are required to be on flea prevention during the summer months. Pets arriving with fleas or ticks will be bathed and treated at the discretion of Dog Party staff, at my expense.
